There is a new option on the Reports and Statistics Menu, Print Single Line Aged Debt, which prints a Summary Aged Debt Report in a more compact format.
CL Mar 2007	Extend Report Criteria - This extends the report criteria on CL reports to incorporate those available in Aged Transactions and provide new ranges and sequences. The reports affected are Aged Transactions, Period Postings, Open Transactions, Supplier Turnover and Transaction History.
DL, CL Mar 2007	Customer & Supplier Notes - This change replaces the Speedbase windows used to process free format sets of notes with a standard Windows text-edit window. Currently OneOffice/Global 3000 maintains customer and supplier notes via various windows that simply list the notes for a specific customer or supplier. With this change applied the display and update of these notes occurs within a standard Windows text-edit control, when used in conjunction with SQL format (Pervasive and MS SQL) Speedbase databases. This control has the advantage of incorporating all the standard Windows text editing features including word wrap and cut and paste. Native database format installations will continue to process notes using the original Speedbase windows.
DL, CL Mar 2007	Enquiries - Enquiries has been enhanced so that when an account is selected transactions are automatically displayed rather than the user having to select the transaction type, there is no change to the dialogue when the 'Transactions' button is pressed.

This is designed to provide restricted access to account balances and budgets based on the user's authorization level. Accounts are suppressed from this enquiry if user's authorisation level is less than that set in Account Maintenance for the account. This provides an alternative view in normal enquiries at account level, showing budget and variance for period and year to date in the periodic analysis window if the budgets are held at account level.

Provide ability to view (via new buttons) additional account detail that was previously only available within Account Maintenance. Clicking this button prompts the user for a transaction type before entering the 'Direct Allocation by Transaction Reference' window. This window allows items to be allocated directly by entering their transaction reference.

PM May 2007	Batch Tracking - Batch tracking may now be switched on for products which have previously been operated as non-batch tracked.
	In FIFO cost environments and for serial numbered products, batch tracking is simply switched on and the batches previously generated by the system to reflect receipts and drive FIFO costing and serial number control become part of the batch track for the affected products.
	In weighted average or standard costing environments, for non-batch tracked, non serially numbered products which are managed by Global 3000 distribution software using a notional "batch zero" per location, all references to batch zero are replaced on affected databases by the number of a batch generated for that location. This may only be done if all delivery lines for the product in Sales Order Processing have been invoiced.
